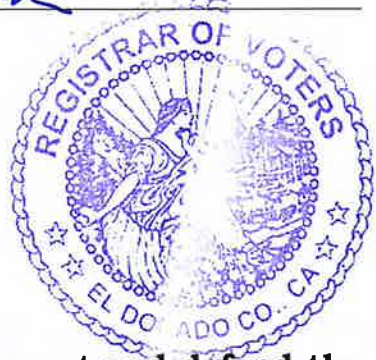

RECOMMENDATION:
