RECOMMENDATION:

The Superintendent is recommending the Board of Trustees receive the listed policy for first reading and possible consideration for action. This policy will complete the updates for the new GAMUT *PolicyPlus*.

BACKGROUND:

GAMUT *PolicyPlus* relies on a consistent set of policy numbers and titles so that updates can be pushed out by GAMUT to school districts whenever there is a policy revision or change in legal resources. This consistent "codification" is also critical to the advanced search features in GAMUT.

Last June, Rescue Union reconciled existing policies to match the new required codification system. The policy presented for review is unique to RUSD. As an elementary district, we use the term "promotion" instead of "graduation" for our students either moving on to middle school or to high school. However, in order to meet the codification requirements in GAMUT *PolicyPlus* policies need to be uniform and therefore the GAMUT names cannot be changed or adjusted.

STATUS:

In order to complete the updates to GAMUT *PolicyPlus*, using the required codification system this policy is presented for first reading and possible consideration.

Policy 6146.5: Elementary/Middle School Graduation Requirements

Original Adopted Date: Pending

In order to recognize successful completion of elementary and middle school education, the Governing Board shall confer certificates of promotion from elementary and middle schools and from special day and evening classes of elementary and middle grades.

Certificates shall be awarded only to students who have completed the course of study prescribed by law and the district. (Education Code 51402)

In addition, students shall meet district requirements for promotion based on grades, assessments or other indicators as specified in Board policy and administrative regulation.

AGENDA ITEM: California Healthy Kids Survey Results

RECOMMENDATION:

The Superintendent is recommending the Board of Trustees receive a report on the California Parents School Survey (CPSS) administered in February of 2022.

BACKGROUND:

The California School Parent Survey (CSPS) is specifically designed to provide data to help foster better parental involvement, one of the required priorities of Local Control and Accountability Plans (LCAP), and to bring parent voice into the school improvement process. The survey aims to raise awareness of how well the school is doing in its parent involvement efforts and what are the needs and concerns of parents that the school should address. It is a means to confidentially obtain parent perceptions about learning and teaching conditions, school climate, and parent-school involvement and relationships, including whether the school environment is academically challenging, caring and welcoming, participatory, safe, and fair.

The CSPS, along with its two companion surveys—the California Healthy Kids Survey (CHKS) and the California School Staff Survey (CSSS) for staff—is a service of the California Department of Education (CDE). These three surveys form the California School Climate, Health, and Learning Survey (CalSCHLS) System. CalSCHLS is the largest, most comprehensive effort in the nation to assess students, staff, and parents at the local level on a regular basis. The surveys provide key data on school climate and safety, learning supports and barriers, and stakeholder engagement, as well as youth development, health, and well-being (see calschls.org) to guide school improvement efforts.

STATUS:

The Board will receive information regarding Rescue Union School District's results for the California School Parent Survey administered to parents in the Rescue Union School District community. The CSPS Core Module provides data on nearly all domains of school climate including: parent involvement, school supports for students, perceived school safety, violence, bullying, caring adult relationships, high expectations, opportunities for meaningful participation, substance abuse, and social emotional supports.



California School Parent Survey (CSPS) Descriptor and Purpose

The California School Parent Survey is a companion to the California Healthy Kids Survey used to foster parent involvement, is one of our measures for the Local Control and Accountability Plan, and brings parent voice into the school improvement process. The purpose of the survey is to:

- > Assess most of the key issues in regard to parent involvement in both the school and their own child's education.
- ➤ Provide feedback to the District on how parents view school climate, including their perspective on the degree to which positive conditions and supports exist at school.

California School Parents Survey Descriptors Cont...

THE IMPACT

In order to improve school climate and the overall social, emotional, and physical health of our students, the results of the California School Parents Survey <u>are examined</u> alongside other data including:

- Parent survey results
- Student listening circle feedback
- Reports from teachers, classified employees, and administrators
- California Healthy Kids Survey (CHKS) results
- Discipline referrals and suspension rates
- Behavioral observations
- Attendance rates



Participation

➤ 519 Elementary School parents participated in the 2021-22 survey. (631 participated in 2020-21)

➤ 242 Middle School parents participated in the 2021-22 survey. (280 Participated in 2020-21)

CSPS results for each individual school have been shared with site administrators.

Site Leadership Teams, School Site Councils, Safety Teams, Student Councils, and other groups will be planning ways to strategically improve student perceptions and outcomes.

It will be especially important to ensure that we continue to provide quality mental health services and social emotional supports, including counseling, PBIS, SEL competency building lessons, etc.

Additionally, we must be mindful of how to continue to provide education to students regarding physical and social emotional health and wellness.

The Federal Government and State intends to allocate significant resources to me health in the new budget.
