This project has prequalification requirements for Mechanical, Plumbing, Electrical, Fire Safety, Site Work, and any other subcontractor performing 5% or more of the total project cost. See Section 00 20 10 – Prequalification Requirements in the specifications.

The work of this project is described as follows:

Construction of a new Two-Story Classroom Building, relocation of portable buildings prior to construction, and removal after construction is complete, including demolition, site work, earthwork, interior architectural work, roofing, interior and exterior finishes, structural, mechanical, plumbing, electrical, and other work as necessary or indicated to construct The Project.

Bidders shall be licensed California contractors, and shall comply with the State Labor Code. Prevailing wage rates are required.

All contractors bidding this project must be registered with D.I.R.

The cost of all bonds shall be included in the bid and paid for by the Contractor. Contractors shall be a licensed California contractor and shall comply with the State Labor Code which requires setting forth in this document the following sections:

**SECTION 1735** – A contractor shall not discriminate in the employment of persons upon public works on any basis listed in subdivision (a) of Section 12940 of the Government Code, as those bases are defined in Sections 12926 and 12926.1 of the Government Code, except as otherwise provided in Section 12940 of the Government Code. Every contractor for public works who violates this section is subject to all the penalties imposed for a violation of this chapter.

**SECTION 1773.2** – In lieu of specifying the rate of wages in the call for bids, and in the bid specifications and in the contract itself, the awarding body may, in the call for bids, bid specifications, and contract, include a statement that copies of the prevailing rate of per diem wages are on file at its principal office, which shall be made available to any interested party on request. The awarding body shall also cause a copy of the determination of the director of the prevailing rate of per diem wages to be posted at each job site.
