Individual Student Reports for this assessment will be mailed home soon. Once again, it is important to keep in mind that the Smarter Balanced Assessment tested students on a new set of standards, which were much more rigorous than we've ever had before. The student reports will also look different.

Students will receive a scaled score for both English language arts and math. Each scaled score will correspond to one of four achievement levels – Standard Exceeded, Standard Met, Standard Nearly Met, and Standard Not Met. Students will also receive scores that relate to the claims of each subject area, such as reading or writing. This is the first time any such scores have been returned to students or schools, and as such, represent baseline data for our students. We are focused on the continual growth of every student, and we use this data to develop learning experiences that match your students' specific needs.

#### CURRICULUM AND INSTRUCTION UPDATE:

This promises to be another exciting and educationally rewarding year for the students of the Rescue Union School District. Our instructional staff is hard at work planning and delivering remarkable learning opportunities to prepare your children to be successful in the ever changing world in which they live. We know that the citizens of tomorrow will need to be technologically prepared, be able to think critically, and be capable of solving complex problems. We are eager to provide our students with highly engaging and dynamic activities to get them ready for their future!

#### Project Lead the Way

At our two middle schools, we are now proud to provide Project Lead the Way (PLTW) courses to students in sixth, seventh, and eighth grades. These courses offer world class Science, Technology, Engineering, and Math (STEM) curriculum. Students participating in our PLTW Design and Modeling course will use state of the art equipment, including professional grade Autodesk Inventor software and high powered computers, to design, analyze, and construct various real-world objects. Those taking the PLTW Medical Detectives course will conduct forensic science activities, including actual DNA extraction and analysis. We will also be offering a PLTW Flight and Space course to teach students all about aeronautical engineering. #### **Technology Enhancements**

Last year, the Rescue Union School District Board of Trustees made a game-changing commitment to the integration of technology into our instructional programs as essential tools for learning. We are also very excited to enhance technology and computer science instruction at all of our schools. This year, we've hired full time technology teachers at each middle school and a full time technology teacher to serve our elementary-aged students as well. To ensure that we are teaching our students the most relevant skills at the appropriate grade levels, our teachers and administrators have spent a great deal of time refining our technology scope and sequence and aligning it to the standards set forth by the International Society for Technology in Education. We've also invested over \$500,000 on new Chromebooks, laptops, iPads, desktop computers, and tablets for our students and teachers, and our staff has logged over 400 combined hours of technology related professional development in August alone! We're very excited to be able to teach your students the technology related skills they'll need for the future, and we are really looking forward to seeing the creative ways they'll use these skills and devices to demonstrate their knowledge and further their own understanding.

### HEALTH INSURANCE INFORMATION



By law, most people are now required to have health insurance or pay a penalty when they file their taxes. Through Covered California, a program from the state of California, qualified legal residents of California and their families can compare health insurance plans and enroll in the one that works best for their needs and budget. Financial assistance is available to qualifying individuals and families to help them pay for health insurance premiums. This means the federal government may pay a portion of the health insurance premium. Individuals and families may also qualify for Medi-Cal benefits.

# **Health Coverage Options**

### Medi-Cal:

- Children, foster youth, pregnant women, adults, US citizens, and immigrants—including those with DACA status—may be eligible for no- or low-cost Medi-Cal.
- Medi-Cal covers immunizations, checkups, specialists, vision and dental services, and more for children and youth at no- or low-cost.
- Medi-Cal enrollment is available year-round.

### **Covered California:**

- Covered California is where legal residents of California can compare quality health plans and choose the one that works best for them.
- Based on income and family size, many Californians may qualify for financial assistance.
- Enroll during Open Enrollment or any time you experience a life-changing event, like losing your job or having a baby. You have 60 days from the event to complete enrollment.

**Undocumented Families** visit: www.allinforhealth.org/resources#Undocumented Immigration status information is kept private, protected, and secure. It will not be used by any immigration agency to enforce immigration laws, but only to determine eligibility for health programs.

# Get Care.

- Find a primary care doctor in your network.
- Schedule an annual checkup for you and your family.
- Make sure to take your child to the dentist.
- Pay your monthly premium if your plan requires it.

# Renew.

- Medi-Cal must be renewed every year. Medi-Cal will mail renewal packet. Complete and return. For help, contact your local Medi-Cal office or call 211.
- Health plans through Covered California must be renewed every year. Renewal information will be mailed at the end of the year, or contact Covered California at 1 (800) 300-1506.

# Sus Opciones de Cobertura de Salud

## Medi-Cal:

- Niños, ióvenes en hogares de crianza, mujeres embarazadas, adultos, ciudadanos de los Estados Unidos, e inmigrantes incluyendo personas con el estatus de Acción Diferida (DACA)—podrían ser elegibles para Medi-Cal gratis o a bajo costo.
- Medi-Cal proporciona vacunas, visitas al doctor de prevención, especialista, oculista y servicios dentales para niños y jóvenes gratis o a bajo costo.
- Inscripción al programa de Medi-Cal está disponible todo el año.

## **Covered California:**

- Covered California es donde los residentes legales de California pueden comparar planes de salud de alta calidad y elegir el que les conviene.
- Dependiendo de los ingresos y el tamaño de la familia, muchos Californianos también podrían calificarán para obtener ayuda financiera.
- Inscríbase durante la Inscripción Abierta o en cualquier momento durante el año que a tenido un evento calificado de vida, como si perdió su trabajo o tuvo un bebé. Tienen 60 días del evento para inscribirse.
