

**Memorandum of Understanding**  
**By and between Placerville Union School District and Rescue Union**  
**Elementary School District**

**TRANSPORTATION SERVICES**

**I. PURPOSE**

This Memorandum of Understanding (MOU) sets forth the agreement between Placerville Union School District and Rescue Union Elementary School District concerning providing transportation services. This MOU establishes an interagency collaboration consisting of the above-mentioned parties whose purpose is to provide Special Education Transportation services for Rescue Union Elementary.

**II. DESCRIPTION OF SPECIAL EDUCATION SERVICE**

The Placerville Union School District will provide transportation services to support a Rescue student's access to her school in Sacramento (Aldar Academy) from August 13, 2024 through June 23, 2025.

**III. TERMS OF AGREEMENT**

The terms of this MOU shall commence on August 13, 2024 and extend through June 23, 2025. Either party may terminate this agreement without cause if given written notice 72 hours in advance.

**IV. FUNDING MECHANISM**

Driver Expenses: All payroll related expenses will be paid by Placerville Union Elementary School district for this transportation route. Half of the cost of salary and benefits will be billed back to Rescue Union Elementary. The current salary and benefits is \$33.44 per hour x 5 hours a day = \$167.20. Rescue will be billed \$83.60 daily. If route hours change, Placerville will notify Rescue of the increase or decrease in hours.

Vehicle Expenses: Placerville Elementary School District will bill Rescue Union School District \$.51 a mile (75% of the current van reimbursement rate) to cover the cost of fuel and vehicle maintenance. The round trip mileage for this route from Placerville Elementary Transportation facility to Aldar learning (including student pickup/drop off points) is 216 miles. For both morning and afternoon round trip routes, the daily vehicle cost charged to Rescue Elementary will be \$110.16.

**Total Daily Transport cost will be \$193.76**

**V. ROLES and RESPONSIBILITIES**

**Placerville Union School District will:**

Provide the personnel and vehicle to transport the Rescue Elementary student to and from school through June 23, 2025

**Rescue Elementary Union School District will:**

Reimburse Placerville Union Elementary for the transportation services as documented above.

**VI. Termination.** Either party may terminate this Agreement at any time up to 72 hours by written notice to the other party.

**VII. Amendments**

Amendments to the MOU may be consummated with a mutual written agreement from both parties.
